財政状況の見通し(H28現在) シミュレーション その1

基礎的前提条件

- 各年度の金額は当初予算計上目標額である。
- 計画期間中の消費税は8%で試算している。
- 平成29年度普通建設事業費には、いわゆるトンネル補助(市の一般財源を伴わない)は含めていない。
- 平成30年度以降の普通建設事業には、庁舎整備等具体的な事業は含めておらず、公共施設等総合管理計画計上の充当可能財源相当(8.9億円)を標準事業費として計上している。
